

Terms & Conditions

SHAPE Bootcamp

Organised by SHAPE Impact Kollektiv

1. Registration and Payment

Registrations are processed in the order they are received and are only considered valid once you receive a formal confirmation email. An invoice will then be issued.

Payment must be made via bank transfer only. All payments are due within 30 business days of the invoice date, unless stated otherwise. Payments must be settled in full, free of any bank or processing fees.

Participation is confirmed only once the full registration fee has been received. For registrations made within one month prior to the bootcamp, proof of payment via bank transfer must be submitted at least 7 days before the event.

If payment has not been received by the due date, a reminder will be issued via email. Payment must then be completed within 14 days of the reminder notice to retain your registration.

2. Substitution and Refunds

If you are unable to attend, you may nominate a substitute participant to take your place at no additional cost. Please notify us in writing at iva@kindlingventures.com to make the change.

We do not offer refunds for cancellations. However, if we have a waitlist of interested participants and one of them is able to confirm and pay within the required timeframe, we may be able to facilitate the substitution through this process. In such cases, we will contact you to discuss the possibility and next steps.

3. Event Cancellation or Postponement by the Organiser

In the unlikely event that SHAPE Impact Kollektiv must cancel the bootcamp due to unforeseen circumstances (including public health concerns), participants will receive a refund of the registration fee, minus an administrative fee of €150.

If the event is postponed, your registration will automatically be transferred to the new date. If you are unable to attend the rescheduled event, you may transfer your registration to another person or request a refund, minus the €50 administrative fee.

Please note that SHAPE Impact Kollektiv is not responsible for any other expenses incurred by participants, such as travel, accommodation, or visa costs.

SHAPE Impact Kollektiv shall not be held liable for any damages or losses related to cancellation or postponement due to events beyond its reasonable control, including but not limited to natural disasters, strikes, transportation disruptions, war, or acts of terrorism.

4. Insurance and Liability

Participants are responsible for their own personal insurance. SHAPE Impact Kollektiv accepts no liability for any injury, loss, or damage to personal belongings during or resulting from the event. We strongly advise all participants to arrange appropriate travel and personal insurance.

5. Personal Information

By submitting a registration form, you consent to the collection and processing of your personal data for the purposes of organizing and running the SHAPE Bootcamp. Your information will be stored securely and will only be used for communication, event coordination, and related follow-up. We will not share your data with third parties without your consent.

Information provided during the booking process, regarding access and/or dietary requirements, may be shared with the venue(s) where the event(s) is/are being held to enable them to cater for your needs.

6. Accommodation

Fees do not include overnight accommodation. Delegates are responsible for booking their own accommodation at courses and the conference.

7. Photography, video and audio recording
